### Introducion

The Net Zero North Wales Network was developed by the North Wales Business Council and has been running since May 2022. The concept of the Network is a straightforward one of bringing together key businesses from across the North Wales private sector along with business representative bodies / local fora and not for profit organisations / Universities / Colleges, around the key elements of delivering decarbonisation and supporting our Journey to Net Zero.

The network shares best practice and advice across businesses / sectors and pulls in and highlights the support and services that are available from public sector bodies and others (at local, regional and national Wales / UK Levels).

With that aim of highlighting supports and services available, Net Zero North Wales has created the Big Green Guide for North Wales. This guide is a 'first run' at trying to encapsulate what is an incredibly complicated landscape covering multiple focus areas and sectors including free, subsidized, and commercial rate product, services and supports with both local and national providers and suppliers.
